RE: COVID-19 Booster Consent Form Clinic

As you now know, the Food and Drug Administration (FDA) has approved a second booster of either the Moderna Vaccine or the Pfizer-BioNTech vaccine for adults over 50 and certain immunocompromised individuals. As such, a memo was sent to all our residents on March 29, 2022, to ascertain interest in receipt of this booster. Thank you for your quick response as it has allowed us the opportunity to quickly secure a booster clinic date with our pharmacy. Please review the below for important information and as always, please reach out should you have any questions.

Step One: COVID-19 Consent Form Clinic (April 14, 2022) ~ Ringling Room

If you are a resident who has indicated intent to receive a booster vaccine, please note the following:

- ✓ You will need to attend our Consent Form Clinic on Thursday, April 14th, 2022, to complete the required paperwork for the pharmacy.
- ✓ NOTE: If you have had a COVID-19 vaccine within the last four months, you will not be able to receive a booster on the day of the booster clinic. If your last vaccine was December 24, 2021 or after, you are ineligible for another vaccine at this time.
- ✓ If your last COVID-19 vaccine was December 23, 2021 or prior, and you would like a booster, ***you must come to our Booster Consent Form Clinic on Thursday, April 14th during your assigned timeframe (see schedule on the reverse page).***
- ✓ ***At the Booster Consent Form Clinic, you must be prepared to indicate which vaccine you would like (Moderna or Pfizer).*** This is critical for pharmacy notification of inventory needed for the booster clinic. NOTE: the FDA and CDC has indicated that vaccine types may be mingled (example: a person who has received two doses of Moderna may receive a Pfizer booster and visa versa).
- ✓ *Over, in yellow*, you will find some information on vaccines that may provide some assistance in making your decision, however we highly recommend you discuss your booster choice with your physician.

Moderna or Pfizer: What Shall I choose:

Both mRNA vaccines offer significant protection from breakthrough infections and hospitalizations and most doctors will tell their patients to 'take what you can get'. Considering we will have both available during our next booster clinic, you will need to decide which vaccine you would like. For older populations, people with risk factors and those immunocompromised, there is some research that Moderna holds a slight advantage against breakthrough infections. A study published in the Journal of the American Medical Association (JAMA) found that although responses to Moderna and Pfizer vaccines dropped six months after vaccination, a test used to detect levels of antibodies in the blood showed higher antibodies in those who had the Moderna vaccine versus Pfizer. *NOTE: A copy of the full study may be retrieved in Gail's office.* Please call if you would like a copy.

COVID-19 Consent Form Clinic Schedule (Ringling Room ~ Thursday, April 14th, 2022)

The best and most efficient way to accomplish this will be to schedule residents alphabetically, by last name. The consent form schedule will be as follows:
